30th Annual Connecticut Women's Hall of Fame Gala and Induction Ceremony;

Celebrating "Women Who Build," the evening included presentations about the living inductees, Carla Squatrito (founder of Carla's Pasta, at one time the largest provider of frozen pasta in the United States), Lisa Cortés (award winning record, TV, and movie producer) and Laura Cruickshank, AIA (university master planner and chief architect for University of Connecticut campuses). All the new inductees presented inspiring acceptance speeches to several hundred attendees, including U.S. Senator Richard Blumenthal, state and local political figures and a dozen pioneering women who were previously inducted into the Hall of Fame. Also inducted this year was the late Regina Winters-Toussaint, advocate for neighborhood planning, a champion of New Haven and the first African-American woman principal of an architecture and planning firm in the State of Connecticut.

Gfeller Laurie LLP has supported the Hall of Fame's mission for many years. Partner Linda Hadley is a founding member of the organization, and the firm regularly attends its educational webinars. In addition to the annual induction gala each fall honoring notable Connecticut women in a variety of fields, the Hall sponsors a generous annual scholarship and educational programs for Connecticut schools including StemFems, Ms. Story and lesson plans for students of all ages. The organization and its supporters engage Connecticut communities with stories of women's struggles and accomplishments, traveling "on the road" talks, a monthly webinar series and promotion of the Connecticut Women's Heritage Trail.




Mitchell House Food Drive 2021


